# 2. Low Income Housing Energy Assistance Program (LIHEAP) & Grant Writing

The Washington Families Clean Energy Credits Program, supported by \$150 million from the state Climate Commitment Act, will assist low- and moderate-income households with the clean energy transition. The Department of Commerce will distribute grants to all electric utilities in Washington that serve residential customers, enabling them to pass on \$200 bill credits to eligible customer accounts by September 15, 2024. The Department of Commerce allocated funds based on the total number of residential customers served by an electric company and the following three criteria, weighted equally, to determine each utility's final grant allocation:

- Utility service areas that are situated in locations experiencing disproportionate environmental health disparities, according to the Washington Environmental Health Disparities Map
- 2. American Community Survey poverty data
- 3. Energy burden data from the U.S. Department of Energy
